Privacy Policy

This Privacy Policy applies to all products, services and websites offered by Know Thyself as Soul Foundation International, Inc. ("KTSI") or its subsidiaries or affiliates.

The Short Version.

We respect you and your privacy and will never purposefully give away (lend, sell or lease) your personal information to anyone without your advance express consent. The only exception to this would be under valid legal process, such as search warrants, court orders, or subpoenas that are applicable according to country or jurisdiction.

The Long Version. Information we collect and how we use it:

Information you provide - When you register online at KTSI or make use of mail or telephone registration or enter a promotion that requires registration, we ask you for personal information (such as your name, email address, telephone, mailing address, etc). For certain services we may also request credit card or other payment account information which we may destroy or maintain per the directive of the individual or organization, in a secure format and location.

Cookies - When you visit KTSI, we send one or more cookies - a small file containing a string of characters - to your computer that uniquely identifies your browser. We use cookies to improve the quality of our service by temporarily storing user preferences and tracking user trends, such as how people search our site and what pages in our site you visit.

Log information - When you use KTSI, our servers automatically record information that your browser sends whenever you visit our website. These server logs may include information such as your Internet Protocol address, browser type, browser language, the date and time of your request and one or more cookies that may uniquely identify your browser.

User communications - When you send email or other communication to KTSI, we may retain those communications in order to process your inquiries, respond to your requests and improve our services.

Affiliated sites - We offer some of our services in connection with other websites. Personal information that you provide to those sites may be sent to KTSI in order to deliver the service. We process such information in accordance with this Policy. The affiliated sites may have different privacy practices and we encourage you to read their privacy policies.

Links - KTSI may present links in a format that enables us to keep track of whether these links have been followed.

We use this information to improve the quality of our website.

Other sites - This Privacy Policy applies to websites and services that are owned and operated by KTSI. We do not exercise control over the sites or links from other sites. These other sites may place their own cookies or other files on your computer, collect data or solicit personal information from you.

General – KTSI only processes personal information for the purposes described in this Privacy Policy and/or privacy notice for specific services. In addition to the above, such purposes include: providing our products and services to users, auditing, research and analysis in order to maintain, protect and improve our services; ensuring the technical functioning of our network; and developing new services.

When you sign up for a particular service that requires registration, we ask you to provide personal information. If we want to use this information in a manner different than the purpose for which it was collected, then we will ask for your consent prior to such use. If we propose to use personal information for any purposes other than those described in this Policy and/or in the specific service notices, we will offer you an effective way to opt out of the use of personal information for those other purposes. You can decline to submit personal information to any of our services, in which case KTSI may not be able to provide those services to you.

We may share with third parties certain pieces of aggregated non-personal information such as the number of users who visited a particular page for example, or how many users clicked on a particular advertisement. Such information does not identify you individually.

KTSI does comply with valid legal process, such as search warrants, court orders, or subpoenas seeking personal information. These same processes apply to all law-abiding companies. As has always been the case, the primary protections you have against intrusions by the government are the laws that apply to where you live.

Information security - We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, as well as physical security measures to guard against unauthorized access to systems where we store personal data. We restrict access to personal information to KTSI employees, contractors and agents who need to know that information in order to deliver, operate, develop or improve our services. These individuals are bound by confidentiality obligations and may be subject to discipline, including termination and criminal prosecution, if they fail to meet these obligations.
